2. Approval of Agenda:

Motion: Approval the agenda by Manley Midgett, 2nd by Ralston James; approved unanimously

 - b) Treasurer's Report submitted through email by Mary Ellen Durham.

Motion: Brad motioned to approve all items in the Consent agenda, Ann McClung 2nd; motion carried.

4. Operations Report

- a) Business Manager (Joette): Financial Report was sent out 1 week ago, does anyone have questions. She told us we have enough money to get through the end of the year due to a successful 2019 PDI
- b) Conference Coordinator Report: Contracts approved for 2021

5. Action Items

a) Finance Committee Motion (Mary Ellen Durham and Finance Committee) Mary Ellen voiced concerns about problems with e-transmissions on our website; many working organizations on the same shared server; sharing with Math Council, amend our budget to cover this, the increase is from \$25 to \$80.

<u>Motion by Finance Committee</u> The Finance Committee moves that the 2020 NCSTA Budget be amended from \$25 to \$80 to cover website utilities charges.

The rationale being a series of problems with our electronic transaction & NCSTA website resulting from server shared with other organizations. During Spring 2019, NCSTA board voted to join the Math Council and share the cost of the dedicated server so problems will be eliminated. Time to move the server. NCSTA pay ½ the cost while NCCTM pays the other half, this has already been approved by the board

and didn't include the increased cost in approved budget. This does require a board vote.

Motion passed unanimously.

b) **Awards Celebration Time/Date** – Alisa Wickliff. Virtual Format Annual Mtg. and 51st Awards Program is proposed to be held November 5th at 4:30-5:45 p.m. Begin advertising this event to our membership. Governor Cooper has been asked to address to our membership

Agenda for the evening: Award winner announced. They can video their receipt of award being presented, Biology and Earth Science awardees announced, Brad Rhew will announce the grant winners; business meeting is required with the passing of the gavel.

<u>Motion by Awards Committee:</u> They move to have our Virtual Annual Meeting and Awards Celebration on Thursday, November 5th from 4:30-5:45 p.m. Motion unanimously passed.

Awards Question from Cliff Hudson; could the district directors present in person, arrange for photo shoot and share on Zoom? Awards will go out at the end of September, there are limited visitors at school with social distancing for presentation (but they could involve district directors in the presentation). Also it was noted that the district directors would be recognized in the slides of their winners.

- c) Conference Planner Committee Mostion (Sandra Weitzel). Kay Swofford put in her resignation as Conference Planner, a small committee was formed. Manley Midgett offered to plan this conference, the conference planner duties would be split into tasks among Joette and Manley, this will save the organization money. Motion:
 - 1) NCSTA Board of Directors accepts Manley Midgett's proposal to act as the 2021 Conference Planner
 - 2) The Conference Planners task will be a division of labor between Manley & Joette Midgett
 - 3) Salary increase to be recommended by the Finance Committee for Joette's additional duties during the 2021 PDI to be approved during the Fall Board Meeting.

Motion passed unanimously.

Constitution & ByLaws Committee (Ann McClung, Chair, with Fanette H. Entzminger) Ann shared the proposed Bylaws amendments. Carol added colors; articles green, blue means changes passed already, flexibility due to virtual delivery to our conference, red action means action items. Daniel Entminger (Fanette's son whose is a lawyer will look at the legalities for dissolution since he is an attorney

- Article 4 Section 2 Membership meetings---meeting if need arises by written request needs 10% of members, need to streamline the verbage, meeting is always held before our PDI
- Article 7 Google Folder (Digital Folder copies of minutes digitally change from paper copies)
- Article 5 already passed by Board of Directors
- Article 10 already passed; dealing with conference planning; whole section highlighted.
- Articles of Incorporation Copy put in digital folder--scan as pdf file (readonly copy). Joette has the original document of these. Any verbiage change requires vote of the membership

Motion: Amendment to the motion by Ann McClung 2nd by MaryKate Holden. Amendment to motion passed.

Article 11 Nominations & Elections

Terms of Office: Secretary and Treasurer (no term limits), but proposed change would allow only two consecutive terms like District Directors. Rationale: gives opportunities for others to get leadership opportunities. However, some members thought there needs to consistency in the Treasurer's position. MaryKate Holden suggested holding off on this change for a bit concern due to the 4 year limit then 2 more years before coming back on board.

Motion: An amendment to the motion amending Article 11 Section 4 be eliminated. Who made the motion? MaryKate seconded. Amendment to motion passed.

 Article 16 - Dissolution of Organization all funds would go to NC Academy of Student Science 5013C Section 2 strike Board of Directors and Executive designates NC Student Academy of Science; very little funding left. Where do we want the funds to go; must be to a 5013C institution

Motion to accept the proposed Constitutional Changes with Amendments
Article 7 the addition of the constitution with bylaws be digitally kept and
removing the proposed change to Article 11 Section 4 was passed with
unanimous consent
